5. **Licenses** - Address or other description of any land in the Council's area for which I and/or my spouse or civil partner has a licence (alone or jointly with others) to occupy for a month or longer.

6. **Corporate Tenancies** – Address or other description of any land where the landlord is the Council and in which the tenant is a body in which I and/or my spouse or civil partner has a beneficial interest.

7. **Securities** – Name(s) of any person or body who (to my knowledge) has a place of business or land in the Council's area and in whom I and /or my spouse or civil partner has a beneficial interest in a class of that person or body that exceeds:

- (a) the nominal value of £25,000 or one hundredth of the total issued share capital (whichever is the lower; or
- (b) the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I, my spouse or civil partner has a beneficial interest exceeds one hundredth of the total shared capital of that class.

NOTE: "Securities" means shares, debentures, debenture stock, loan stock bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society. The nominal value of shares is the face value of those shares (the value recorded on the share certificate).
