- (b) the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I, my spouse or civil partner has a beneficial interest exceeds one hundredth of the total shared capital of that class.

**NOTE:** "Securities" means shares, debentures, debenture stock, loan stock bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society. The nominal value of shares is the face value of those shares (the value recorded on the share certificate).
